# VdF – The Players' Association supports the "Justice for Players" class action lawsuit

European football is currently experiencing a legal development of far-reaching significance that will affect approximately 10,000 Austrian players. The Justice for Players (JfP) initiative is a Europewide movement that aims to strengthen players' rights and secure fair compensation for financial losses suffered.

Following the French, Dutch and Belgian players' unions in joining this initiative, the VdF – Die Spielervereinigung (as the only internationally representative players' union in Austria) is now also supporting the class action lawsuit against FIFA in official partnership and cooperation with JfP. Acting as advisor to JfP and contact person for the VdF is none other than Jean-Louis Dupont, Bosman's lawyer and legal architect of the revolutionary Bosman ruling. The aim is to provide players in Austria with comprehensive information and give them easy access to the proceedings.

But what exactly is this about? In October 2024, the European Court of Justice (ECJ) handed down a landmark ruling in the *Lassana Diarra* case. Certain FIFA transfer regulations were declared unlawful because they restricted players' professional freedom and salary development. This affects all professional and semi-professional players who were under contract in an EU member state or the United Kingdom between 2002 and today, regardless of their gender or nationality.

According to an economic analysis by Compass Lexecon, these regulations led to systematic income deflation averaging eight per cent of total salaries, plus interest on arrears. If the class action is successful, participating players may receive compensation for the financial damage incurred. Participation for players is anonymous and free of charge.

In addition, the class action aims to persuade FIFA to adopt the reforms to the transfer system required by EU law and to involve the players' unions in this process.

Lucia Melcherts, Chair of Justice for Players: "The VdF's decision to support Justice for Players' class action lawsuit is another important step towards ensuring that the rights of professional footballers are protected under European law. As confirmed by the European Court of Justice, players' salaries in Austria, as in the rest of the EU and the United Kingdom, are affected by FIFA's unlawful transfer rules. With our lawsuit, we not only want to secure financial compensation for players for their loss of income, but also achieve a lasting reform of the rules.

For JfP, the VdF was the obvious partner for Austria due to its long history and high representativeness, as well as the fact that the VdF is the Austrian member of FIFPRO Europe, the European players' organisation recognised by the European Commission that represents professional players in European social dialogue.

With the support of the VdF, following the UNFP, the VVCS and United Athletes, the movement for a transparent, fair and lawful framework that is more equitable for players continues to gain momentum across Europe.
